SPECIAL ORDER 17-10

SUBJECT: ENFORCEMENT OF LAMC § 63.44 B (14)(b) - BEACH HOURS

The City of Los Angeles is involved in litigation over the enforcement of LAMC 63.44 B(14)(b) regulating hours of access to beaches within the City of Los Angeles <u>including Cabrillo Beach and fishing pier</u>.

LAMC 63.44 B (14)(b) states the following:

No person shall enter, remain, stay or loiter in any park which consists of an ocean area, beach, or pier between the hours of 12:00 midnight and 5:00 o'clock a.m. of the following day [...].

As a result of this litigation the City has agreed to the following temporary restriction which will remain in force until this order is rescinded:

No individual shall be cited or arrested for violating Section 63.44(B)(14)(b) unless such individual:

- 1) is provided with a verbal warning that the park is closed to the public;
- 2) is given a sufficient and reasonable time to comply with the warning, and
- 3) refuses to comply.

Department personnel enforcing Section 63.44(B)(14)(b) shall document on the citation or arrest report that a warning was provided and include the amount of time provided to comply with the warning. Please direct any questions to Lt. McCloskey.
