PURPOSE:

MODIFICATION OF REQUIRED FORM AND PROCEDURES

This Special Order revises Special Order 11-01.1 by implementing a new SAR form and modifying the SAR filing process.

Los Angeles Port Police officers shall continue to report suspicious activities with any possible nexus to terrorism using the L.A.P.D. Suspicious Activity Report (SAR) form and report filing procedures. Recently L.A.P.D issued a new SAR form, Form 03.24.00. This form will replace the L.A.P.D Investigation Report form as the SAR form. The new form and notebook divider are available on the network drive.

In addition to the SAR reporting procedures currently implemented, SARs that have been approved by the Port Police Watch Commander shall be uploaded to the Tips and Leads Section on the JRIC website at www.jric.org. A notation shall be made in the report that this has been done. No information shall be transmitted to the JRIC without a SAR that has been approved by the Watch Commander.
